## SOA COMMITTEE ON LIFE INSURANCE MORTALITY AND UNDERWRITING ANNOUNCES FOUR NEW SURVEYS

The Society of Actuaries (SOA) Committee on Life Insurance Mortality and Underwriting Surveys has begun work on four new surveys that should provide some interesting and timely information to the industry. We ask for your support in responding to the surveys when you see them in order to provide as wide an industry perspective as possible. Note only one response per company is needed (and desired).

The new surveys cover:

- Early duration claims experience and underwriting practices to prevent early duration claims.
  - How companies are handling life settlements.
- Underwriting practices and mortality related to foreign travel.
  - Alternative solutions to manage mortality risk.

The Mortality and Underwriting Survey Committee comprises underwriters and actuaries representing

direct companies, fraternals, reinsurers and consulting firms. The survey committee was created in 1998. We have completed a number of surveys since then, including ones on preferred underwriting (1998, 2003, 2005), older age underwriting practices (2001, 2007), lab tests (1999), technology (2002), risk management (2005) and business decisions (2007).
