•General Conversion Settings - Press

•File Options - Compatibility with Acrobat 8.0 (PDF1.7); Left Binding; 2400 dpi Resolution; •Compression -Images –ZIP; OK for Text and Line Art;

•Fonts - Embed all fonts

•Color Settings - Settings File - none; Leave color unchanged : Document Rendering Intent -Preserve; Device-Dependent Data - none; •Advanced - allow Postscript file to override
